320	<b>Wood turned and shaped and other wooden goods, not elsewhere classified.</b> Bobbins, bowls, bungs, brush blocks, dowels, handles, marquetry, oars, rollers, rolling pins, spools, picker sticks for looms, and other turned and shaped wooden articles and wood carvings; also miscellaneous articles such as wooden dishes, trays, meat boards, toothpicks, washboards, clothespins, ironing boards and tables, grain measures, tailors' pressing blocks, flagpoles, masts and spars, ladders, etc.

406	<b>Labels and tags.</b> Labels and tags of paper, celluloid, metal, cardboard, etc.; baggage and other checks, door and name plates, metal badges and checks; labels for clothing; patent indexes; laundry and shipping tags; pin tickets, etc.
407	<b>Paper.</b> All kinds of paper and paper boards, such as newsprint, book, cover, writing, wrapping, tissue, absorbent, and building papers. Converted-paper products <i>made in paper mills</i> are included in this classification. An independent factory making converted-paper products is given its specific industry classification.

502	<b>Engravers' materials.</b> Copper, zinc, steel, and other metal plates for engravers' use; wood blocks for use in wood engraving and photo-engraving; lithographic stones; etc.

509	<b>Printing and publishing, music.</b> Books of music and sheet music. (a) Printing and publishing. (b) Publishing without printing.

608	<b>Chemicals, not elsewhere classified (see also Coke; Compressed and liquefied gases; Druggists' preparations; Explosives; Fertilizers; Gas, manufactured; Oils, essential; Paints and Varnishes; Patent and proprietary medicines and compounds; Rayon and allied products; Tanning materials, natural dyestuffs, mordants and assistants, and sizes; Turpentine and rosin; Wood distillation and charcoal manufacture).</b> All chemicals except those produced in the allied industries specified above. They are grouped under six heads, namely: (I) Acids. (II) Nitrogen compounds, including ammonium and cyanogen compounds. (III) Sodium compounds. (IV) Potassium compounds, including potash from original sources. (V) General inorganic compounds, including alums and the various salts and compounds of metals (antimony, arsenic, copper, gold, iron, etc.), rare earths, insecticide chemicals, etc. (VI) General organic compounds, including the alkaloids and their salts; coal-tar crudes, intermediates, and finished coal-tar products; synthetic photographic chemicals, flavors, essential oils, perfumes, narcotics, pharmaceuticals, etc.; plastics, such as the pyroxylin plastics, rubber substitutes, etc., including finished goods made by the establishment that makes the plastic; formaldehyde; glycerin; carbon products; ether; acetone; etc.

903	<b>Boot and shoe findings, not made in boot and shoe factories.</b> Shoe pegs, bows, clasps, stays, metal tips and heelplates, toe caps, buckles, boot and shoe laces, heel caps, rands, staples, counters, shanks, wooden heels, shoe trimmings, etc.
904	<b>Boots and shoes, other than rubber.</b> Boots, shoes (high and low cut), pumps, slippers, sandals, putties, leggings, overgaiters, and allied footwear, made of leather, felt (purchased), canvas, or other textile fabrics. Establishments engaged in contract work on materials furnished by others, in connection with the manufacture of boots, shoes, etc., are also included in this industry. (Felt shoes, etc., made in mills which manufacture the felt are classified in "Felt goods.")

### Industry Group 10.—STONE, CLAY, AND GLASS PRODUCTS

1001	<b>Asbestos products, other than steam packing or pipe and boiler covering.</b> Asbestos building materials, such as roofing, sheathing, siding, and flooring; other asbestos products, such as table mats and pads, holders for flatirons, packing for ice boxes and refrigerating cars, antifriction facings and linings, and insulating material.
1002	<b>Cement.</b> Portland cement; hydraulic, fireproof, and slag cement, etc.
1003	<b>China firing and decorating, not done in potteries.</b> China firing and decorating for the trade. (Small establishments engaged in such work for private customers or to individual order are not included.)
1004	<b>Clay products (other than pottery) and nonclay refractories.</b> Building brick, fancy and ornamental brick, vitrified brick, fire brick, sewer pipe, drain tile, etc., and other refractories.
1005	<b>Concrete products.</b> Building blocks, building trimmings, cement roofing tile, etc., and other articles, such as laundry tubs, burial vaults, etc., manufactured from a combination of stone or gravel and sand, with cement.
1006	<b>Crucibles.</b> Crucibles of all sizes, made largely from fire clay, German clay, kaolin, and plumbago.
1007	<b>Emery wheels and other abrasive and polishing appliances.</b> Abrasive wheels, whether of emery, corundum, or other material; polishing and buffing wheels, belts, and disks.
1008	<b>Glass.</b> Building glass, pressed and blown glass, wire glass, etc., and glass containers of all kinds.
1009	<b>Glass products (except mirrors) made from purchased glass.</b> Glass cutting, glass beveling, bending sheet glass, engraving on glass, making glass labels, staining and ornamenting glass, and manufacturing safety glass.
1010	<b>Graphite, ground and refined.</b> The extraction from the ore and the refining of graphite (plumbago or black lead).
1012	<b>Hones, whetstones, and similar products.</b> Hones, whetstones, oilstones, scythestones, lawn-mower sharpeners, rubbing stones for hardware finish, rubbing brick, shoemakers' sandstones, etc.
1013	<b>Lime.</b>
1014	<b>Marble, granite, slate, and other stone products.</b> Monuments, tombstones, and other articles for cemetery uses; roofing slate, slate blackboards, and other slate work; builders' and plumbers' marble, granite, and other stone work; soapstone work; all other stone work, except millstones, grindstones, pulpstones, and hones and whetstones.

1101	<b>Bolts, nuts, washers, and rivets, not made in plants operated in connection with rolling mills.</b>
1102	<b>Cast-iron pipe.</b> Cast-iron gas, water, soil, and other cast-iron pipe.
1103	<b>Cutlery (not including silver and plated cutlery) and edge tools.</b> Knives, razors, scissors, shears, augers, gimlets, planes, meat choppers, axes, hatchets, and implements of a similar character. Does not include silver, nickel-silver, or plated knives, forks, etc., which are classified under "Plated ware" or "Silversmithing and silverware."
1104	<b>Doors, shutters, and window sash and frames, metal.</b>
1105	<b>Files.</b> The manufacture and recutting of files, rasps, etc.
1106	<b>Firearms.</b> Rifles, shotguns, revolvers, pistols, stocks, parts, etc.
1107	<b>Forgings, iron and steel, not made in plants operated in connection with rolling mills.</b> Light and heavy drop and steam-hammer forgings, chains, anchors, axles, car wheels, fogs, etc.
1108	<b>Galvanizing and other coating, not done in plants operated in connection with rolling mills.</b> Galvanizing or coating sheet steel or iron or formed products with zinc; coating sheet steel or iron or formed products with aluminum and lead; refinning of cans and utensils.
1109	<b>Hardware not elsewhere classified.</b> Locks, car seals, seal presses, brackets, andirons and fireplace goods, and trunk trimmings; builders', cabinet, saddlery, harness, car, carriage, casket, furniture, piano, and organ hardware; vacuum bottles and containers.
1110	<b>Iron and steel: Blast furnaces.</b> Pig iron and blast-furnace ferro-alloys.
1111	<b>Iron and steel, processed.</b> Establishments engaged chiefly in casehardening, tempering, rust-proofing, or otherwise specially treating iron or steel.
1112	<b>Iron and steel: Steel works and rolling mills.</b> Establishments engaged in the manufacture of steel or in the rolling of hot iron and steel. Products include steel ingots and direct steel castings; rolled iron and steel, such as rails, splice bars, rail joints, bars and rods, tin-plate bars, wire rods, structural shapes, hoops, bands, and cotton ties; plates and sheets, including black plates and sheets for linings; nail and tack plates; car axles, rolled and hammered; car wheels; armor plate; gun forgings, etc.

Leaf springs—railway, motor-vehicle, carriage, wagon, etc.; hot-wound springs, railway and other; flat springs, coiled. (Does not include the manufacture of light coiled springs, which are products of the Wirework, not elsewhere classified, industry.)

### Industry Group 12.—NONFERROUS METALS AND THEIR PRODUCTS

1201	Aluminum manufactures. Aluminum castings, bars, plates, and sheets; aluminum ware, such as kitchen utensils and household appliances; and other aluminum goods, such as specialties, airplane parts, engine and machine parts, etc.
1202	Clocks, clock movements, time-recording devices, and time stamps.
1203	Collapsible tubes.

1204	Copper, tin, and sheet-iron work, including galvanized-iron work, not elsewhere classified. Sinks, tanks and bins, cooking apparatus, smokestacks, stove and furnace pipes and elbows, stove and furnace casings, cornices, roofing, skylights, ventilators, corrugated-iron culverts, etc., made from sheet copper, tin plate or sheet iron; coppersmithing and sheet-iron work, including galvanized-iron work. (Factory or shop work only.)
1205	Electroplating. Electroplating of all descriptions, such as nickel plating, silver plating, etc. In many cases this work is done on a contract basis on articles furnished by others.
1206	Fire extinguishers, chemical. Chemical engines, hose carts, and other apparatus and appliances for fire extinguishing through the use of chemicals; chemical preparations for use with such apparatus and appliances; hand grenades for fire extinguishing, etc.
1207	Gas and electric fixtures; lamps, lanterns, and reflectors. Gas fixtures, chandeliers, domes, burners, mantles, etc.; electric fixtures, holders, electrolights, brackets, portables, etc.; combination gas and electric fixtures; motor-vehicle lamps, carriage and wagon lamps, all other lamps; reflectors.
1208	Gold leaf and foil. Gold leaf and foil for decorators, dentists, etc. (made by establishments generally known as goldbeaters).
1209	Gold, silver, and platinum, reducing and refining, not from the ore. The reduction and refining of precious metals, chiefly from the waste and sweepings of factories engaged in the manufacture of jewelry, silverware, etc.
1210	Jewelry. Rings, pins, bracelets, and chains; diamond setting and mountings; gold trimmings for umbrellas, canes, etc.; rolled plate, filled wire, etc.
1211	Needles, pins, hooks and eyes, and snap fasteners. Machine and hand needles, knitting and sewing; toilet, hat, and safety pins, wire hairpins, etc.; glove fasteners, snap fasteners, hooks and eyes, etc.
1212	Nonferrous-metal alloys and products, not including aluminum products. (Formerly three separate industry classifications—"Babbitt metal, white metal, type metal, and solder"; "Brass, bronze, and other nonferrous alloys, and manufactures of these alloys and of copper, not specifically classified"; "Lead: Bar, pipe, and sheet.") Lead, bar, pipe, and sheet; antifriction-bearing metals; type metal; solders; bars and rods of brass, bronze, and other nonferrous alloys, such as Monel metal and German silver; plates, sheets, rods, tubing, wire, castings, and machinery fittings made from copper or zinc or from brass, bronze, or other nonferrous alloys; various finished products, such as die-castings, extruded shapes, electrical supplies, car and engine brasses, refined brass work, oiling devices, spigots, hose couplings, stair plates and rods, fenders, screen plates, spun metal, bells, etc. Copper ingots are normally products of the "Smelting and refining, copper" industry. Establishments engaged in the manufacture of wire from purchased bars or rods are classified in the "Wire, drawn from purchased bars or rods" industry. Establishments engaged primarily in the manufacture of gas and electric fixtures, hardware, and plumbers' supplies are not classified in this industry, these lines of manufacture being covered by separate classifications.
1213	Plated ware. Articles plated with gold, silver, or other metals; articles made of nickel-silver or pewter.
1214	Silversmithing and silverware. Solid silver knives, forks, spoons, and other flatware; solid silver hollow ware, toilet ware, ornaments, ecclesiastical ware, novelties, cane and umbrella handles, etc.
1215	Smelting and refining, copper.
1216	Smelting and refining, lead.
1217	Smelting and refining, metals other than gold, silver, or platinum, not from the ore. The smelting and refining of scrap metals and dross of all kinds, except gold, silver, and platinum, for which there is a special classification.

### Industry Group 13.—MACHINERY, NOT INCLUDING TRANSPORTATION EQUIPMENT

1301	<b>Agricultural implements.</b> (1) Planting and fertilizing machinery—corn planters, cotton planters, potato planters, grain drills, combined listers and drills, beet drills, broadcast seeders, transplanters, fertilizer distributors, lime spreaders, manure spreaders, etc.; (2) Plows and listers—moldboard plows, disk plows, listers, ridge busters, subsoilers, plowstocks, steel plow shapes, etc.; (3) Harrows, rollers, pulverizers, and stalk cutters; (4) Cultivators and weeders, etc.; (5) Harvesting machinery—grain binders, grain headers, combines (harvester-threshers), rice binders, cornbinders, corn harvesters, corn picker-huskers, corn snappers, reapers, potato-digging machines, pea and bean harvesters, beet lifters, etc.; (6) Haying machinery—mowers, horse-rakes (hand rakes to be classified under "Tools, not including edge tools, machine tools, files, or saws"), tedders, loaders, stackers, and combined sweep rakes and stackers, windrowers and bunchers, etc.; (7) Machines for preparing crops for market or use—threshers, clover hullers, ensilage cutters, corn shellers, corn huskers and shredders, hay presses, feed grinders and crushers, grain cleaners and graders (including fanning mills), potato sorters and graders, cane mills (farm size), sirup evaporators and kettles, sirup-evaporator furnaces, cider mills, etc.; (8) Miscellaneous agricultural implements—grain cradles, straw spreaders, seed-potato cutters, eveners, hay carriers, forks, and slings, tracks for hay carriers, scythes, etc.
1302	<b>Cash registers and adding, calculating, and card-tabulating machines.</b> Adding machines and adding attachments for typewriters, cash registers and similar devices, fare registers and recording fare boxes for railway cars, ticket-counting machines; coin changers, rotary wage tables, slide rules, card-punching, card-sorting and card-tabulating machines, and other calculating and computing machines and devices.
1303	<b>Electrical machinery, apparatus, and supplies.</b> All classes of machinery, apparatus, and supplies for employment directly in the generation, storage, transmission, or utilization of electric energy. Products include electric locomotives, dynamos, motors, batteries, transformers, switchboards, panel boards, cut-out cabinets, carbons, arc and incandescent lamps, searchlights, projectors and focusing lamps, sockets, transmitters, receivers, lightning arresters, rheostats and resistances, electric welding apparatus, electric therapeutic apparatus, switches, signals, telegraph and telephone apparatus, fire-alarm apparatus, radio apparatus, miscellaneous electric household appliances, etc.
1304	<b>Engines, turbines, tractors, and water wheels.</b> Steam engines—reciprocating, turbine, traction, etc.; internal-combustion engines—Diesel type, aviation, marine, motor-vehicle, and motorcycle engines, tractors (farm, road, and other), etc.; water turbines, water wheels, and water motors.
1305	<b>Foundry and machine-shop products, not elsewhere classified.</b> All products of boiler shops, foundries, and machine shops, not classified in any of the other industries in this group nor in any of the industries in Groups 11 and 12.
1306	<b>Gas machines, gas meters, and water and other liquid meters.</b> Machines for manufacturing gas, acetylene-gas generators, gas meters, water meters, gas and water regulators, etc.
1307	<b>Machine tools.</b> Power-driven machines for cutting or shaping metals, such as lathes, planers, drilling machines, etc. Machine tools are designed for more or less general use, as distinct from machines designed for manufacturing special articles. Portable hand tools (power-driven) for calking, riveting, and driving screws are also included under this classification.

1311	<b>Scales and balances.</b> Scales, balances, weighing machines and apparatus, automatic and computing weighing machines, etc.
1312	<b>Sewing machines and attachments.</b>
1313	<b>Textile machinery and parts.</b> All classes of textile machinery and parts, including machinery for bleaching, dyeing, printing, mercerizing, finishing, etc.
1314	<b>Typewriters and parts.</b> Typewriters and parts of typewriters.
1315	<b>Washing machines, wringers, driers, and ironing machines, for household use.</b> Washing machines, wringers, drying machines, and ironing machines, whether operated by mechanical power or by hand, for use in homes. (Laundry machinery for use in commercial laundries only is classified under "Foundry and machine-shop products, not elsewhere classified.")
1316	<b>Windmills and windmill towers.</b> Windmills and accessories and parts; windmill towers.
1318	<b>Machine-tool accessories and small metal-working tools, not elsewhere classified.</b> Attachments, fixtures, and small tools (chucks, jigs, cutters, drills, reamers, taps, etc.) for use chiefly with machine tools; precision measuring tools (micrometers, verniers, and gauges).

### Industry Group 14.—TRANSPORTATION EQUIPMENT, AIR, LAND, AND WATER

1401	<b>Aircraft and parts.</b> All types of aircraft (including balloons) and parts.
1402	<b>Carriage, wagon, sleigh, and sled materials.</b> Bodies, tops, cushions, hubs, felloes, spokes, wheels, whiffletrees, carriage boots and aprons, axles, dashboards, neck yokes, whipsockets, and other materials and parts except springs, which are separately classified.
1403	<b>Carriages and sleds, children's.</b> Baby carriages, "walkers," go-carts, sleds, doll carriages, children's velocipedes and tricycles, children's express wagons, etc.
1404	<b>Carriages, wagons, sleighs, and sleds.</b> Complete carriages, wagons, sleighs, sleds, pungs, handcarts, pushcarts, and wheelbarrows.
1405	<b>Cars, electric and steam railroad, not built in railroad repair shops.</b>
1406	<b>Locomotives, not made in railroad repair shops.</b> All kinds of steam and internal-combustion locomotives. (Electric locomotives are classified under "Electrical machinery, apparatus, and supplies.")
1407	<b>Motor-vehicle bodies and motor-vehicle parts.</b> Establishments engaged primarily in the manufacture of (a) motor-vehicle bodies; (b) parts and accessories such as gears, wheels, radiators, bumpers, axles, rear-axle housings, axle shafts, shock absorbers, windshields, rims, frames, horns, windshield wipers, and various other assemblies and parts, not including complete chassis, which are classified under "Motor vehicles." (a) Bodies. (b) Parts and accessories.
1408	<b>Motor vehicles, not including motorcycles.</b> All complete four-wheeled motor vehicles—automobiles, trucks, motor busses, etc.—complete chassis and trailers.
1409	<b>Motorcycles, bicycles, and parts.</b> Complete motorcycles, side cars, and bicycles, and motorcycle and bicycle parts, such as saddles, seat posts, frames, gears, handlebars, chains, etc. Establishments which manufacture complete motorcycles or bicycles by merely assembling purchased parts are included in this classification.

Building of all classes of steel and wooden vessels, including yachts, rowboats, canoes, etc.; repairs to such vessels; masts, spars, and other accessories for such vessels; rigging of such vessels (equipping with ropes, chains, etc., which support or raise and lower masts and spars, or serve to set and trim sails).

### Industry Group 15.—RAILROAD REPAIR SHOPS

1501 **Car and general construction and repairs, electric-railroad repair shops.**  
Shopwork done by electric-railroad companies; consists principally of repairs to rolling stock and bridges belonging to the company operating the shop. Some shops, however, build new cars, and some perform repair work for other railroad companies.

1502 **Car and general construction and repairs, steam-railroad repair shops.**  
Shopwork done by steam-railroad companies; consists principally of repairs to rolling stock and bridges belonging to the company operating the shop. Some shops, however, build new cars and locomotives, and some perform repair work for other railroad companies.

### Industry Group 16.—MISCELLANEOUS INDUSTRIES

1601 **Artificial and preserved flowers and plants.**  
Manufacture of artificial leaves, palms, grasses, wreaths, plants, foliage and vines, buds, and fruits; manufacture of wax flowers; preservation of flowers, plants, stems, and other material for the manufacture of artificial flowers.

1603 **Artists' materials.**  
Canvas board; prepared canvases or frames; oil colors; air brushes for portrait work; air compressors for art work; easels; drawing tables and boards; palettes; sketch boxes; pantographs; wax, dustless, and other crayons; tailors' chalk; crayon pencils; gold and bronze mixtures, powders, paints, and size; gold and aluminum enamel and paint for china painting; pyrography goods, including platinum points; drafting materials; drawing ink; etc.

1604 **Brooms.**  
Brooms, whisk brooms, etc., made from broom corn or fiber; street and stable brooms made from heavier materials.

1605 **Brushes, other than rubber.**  
Paint, sash, floor, whitewash, and other brushes, not including those made of rubber.

1606 **Buttons.**  
All kinds of buttons, parts of buttons, and button blanks or molds.

1607 **Carbon paper and inked ribbons.**

1608 **Cigars and cigarettes.**  
(a) Cigars.  
(b) Cigarettes.

1609 **Combs and hairpins, not made from metal or rubber.**  
Combs and hairpins for dressing or ornamenting the hair, made from fiber, bone, horn, tortoise shell, celluloid, and ivory; also novelties for ladies' headdress, barrettes, hair-puff pins, hair ornaments, comb mountings, etc.

1610 **Dairymen's supplies; creamery, cheese-factory, and butter-factory equipment; and poultrymen's and apiarists' supplies.**  
(a) Incubators and brooders. (b) Other poultrymen's supplies, such as coops, hovers, houses, incubator regulators, feeders, feed cookers, crates and chicken-shipping boxes, etc. (c) Cream separators, centrifugal and gravity, and accessories. (d) Other dairymen's, creamery, cheese-factory, and butter-factory supplies and equipment, such as automatic sanitary butter machines; butter workers, vats, colors, packers, ladles, and molds; cheese presses, and bandages; rennet extract and lactic ferment; churns; dairy tinware; milk tanks, coolers, etc.; pasteurizers; portable stalls; etc. (Creamery, butter-factory, and cheese-factory machinery, except cream separators, is to be classified under "Foundry and machine-shop products, not elsewhere classified," Group 13). (e) Apiarists' supplies, such as bee escapes, bee veils, comb foundation, hives, honey boxes and sections, etc.

1611 **Dental goods and equipment.**  
Artificial teeth, filling material, dental alloys, plate material, carbundum disks and wheels, mandrels, casting machines, dental files, impression materials, gold crown and bridge work, rubber plate work and suction plates and cups, workshop tools, etc. (Dental instruments are classified under "Instruments, professional and scientific.")

1612 **Fancy and miscellaneous articles, not elsewhere classified.**  
Beaded articles, celluloid novelties, art novelties, holiday goods, photo jewelry and buttons, inlaid veneer work, silk watch chains, burnt-wood articles, lamp shades, bric-a-brac, composition ornaments, needle and pin books, decalcomania work (when not on china or glass), and many other miscellaneous small articles not covered by distinct classifications.

1613 **Feathers, plumes, and manufactures thereof.**  
Production of fancy feathers, plumes, quills, and articles made principally from feathers and plumes; curling, dyeing, and renovating ostrich feathers for the trade. (Establishments engaged wholly or mainly in the performance of custom work are not included.)

1614 **Foundry supplies.**  
Foundry supplies, such as cement for castings, core oils and compounds, chaplets, wax and flux, "parting" composition, flasks, sieves, pipe blacking, plumbago, etc.

1615 **Fur goods.**  
Fur and fur-lined coats and overcoats, fur neck pieces of all kinds, fur hats and caps, fur trimming, fur robes, all other fur and fur-lined goods, sheep-lined garments.

1616 **Furs, dressed.**  
The scraping, currying and tanning, and bleaching and dyeing of pelts for use in the manufacture of fur goods, and the dressing of hair and bristles. In many cases this work is done for others on a contract basis.

1617 **Hair work.**  
Wigs, switches, braids, puffs, and related articles made largely from human hair but in some cases from mohair or other animal hair.

1618 **Hand stamps and stencils and brands.**  
Rubber and metal stamps, dies, seals, and presses, steel letters and figures, check protectors, date and time stamps, numbering machines, copper and brass stamps for marking textiles, steel shoe stamps, etc. Stencils made of brass, steel, or other material for use in painting or marking or in addressing machines; branding irons (irons to be heated and used in marking casks, boxes, articles of merchandise, etc.).

1619 **Hats, straw, men's.**  
The manufacture of men's straw hats and the bleaching and finishing of Panama and other straw hats. (Trimmed hats for women and children are classified under "Millinery, not elsewhere classified.")

1620 **Instruments, professional and scientific.**  
All kinds of anthropometrical, astronomical, physiological, chemical, and physical apparatus for educational and commercial purposes; drafting instruments; surveyors', nautical, and similar instruments; surgical, dental, orthopedic, and veterinary instruments, etc. Among the numerous products are the following: Speedometers, barometers, thermometers, compasses, binnacles, dental mirrors, micrometers, and spectroscopes.

1621 **Ivory, shell, and bone work, not including buttons, combs, or hairpins.**  
Articles made from ivory, shell, mother-of-pearl, horn, or bone, not elsewhere classified. Products include mosaics, knife handles and tips, fobs, buckles, and other fittings for jewelers' use, manicule implements, watch chains, stick pins, hatpins, inlaying for musical instruments, etc.

1622 **Jewelry and instrument cases.**  
Cases, trays, fancy boxes, etc., for jewelry, instruments, cutlery, eyeglasses, combs, compasses, cigarettes, pipes, toilet sets, etc.

1623 **Lapidary work.**  
Cutting and polishing of diamonds and other precious or semiprecious stones; drilling of pearls; recutting and setting for the trade; preparation of jewels for surveyors' and electrical instruments and for watches and chronometers, and of real and imitation stones for emblems. Much of the work is done on a contract basis on materials owned by others.

1624 **Mattresses and bed springs, not elsewhere classified.**  
Mattresses filled with hair, cotton, felt, moss, or similar material; wire springs for use on beds, couches, and cots; spring cushions.

1625 **Models and patterns, not including paper patterns.**  
Patterns and models for use in making matrices or molds for casting metal or for making brick, glassware, etc.; hat blocks, pottery braces, wax figures, dress and show forms, stamping outfits, etc.

1626 **Motion pictures, not including projection in theaters.**  
All processes and activities connected with the production of motion pictures, not including their projection in theaters.

1629	<b>Musical instruments: Organs.</b> Complete organs (pipe and reed).

Although some establishments produce complete spectacles and eyeglasses of various kinds, most of them either grind the lenses or make the frames but are not engaged in both lines of manufacture. Products include automatic eyeglass holders, eye shields and shades, eye-testing sets, eyeglasses, frames, and mountings, goggles, lenses, microscopes, telescopes, opera glasses, ophthalmic instruments and apparatus, optometers, photographic and projection lenses and prisms, photomicro and micro-projection apparatus, refractometers, spectrometers, optical measuring instruments, range finders, fire-control apparatus, and optical glass, machinery, and tools.

( <i>Stone paving blocks, including granite, are classified under "Marble, granite, slate, and other stone products."</i> ) Mixed paving materials include artificial asphalt, asphalt mixture for top coat and binder, bituminous and other cements, liquid asphalt, tar concrete, etc.
1633	<b>Pencils, lead (including mechanical).</b> Complete lead pencils, wooden; pencils with removable holders and removable leads; holders only; leads only.
