

# U. S. CENSUS OF HOUSING: 1960

## Availability of Published and Unpublished Data

### INTRODUCTION

This booklet presents, in outline form, the items covered in the published reports and in the principal unpublished tabulations of the 1960 Census of Housing. The items are described and the geographic areas for which the various tabulations have been made are identified.

The publication program for the 1960 Census of Housing consists of seven volumes, the PHC(1) series of reports prepared jointly by the Housing Division and the Population Division showing data by census tract, and the HC(S1) series of reports, Special Reports for Local Housing Authorities.

Unpublished tabulations are available as photocopies, microfilm, or on magnetic computer tape. These tabulations include tables designed to provide data for areas not covered in the published reports, tables for small areas prepared in the course of processing data for publication, and special tabulations prepared for the account of public and private agencies.

A general index of the contents of the publications lists alphabetically all the items in the individual subject guides, and shows the volumes and series in which each appears. The subject guide for each volume or series lists the items covered. For each item it shows the numbers of the tables in which the item appears, any cross-tabulations, as necessary shows the areas for which data are available, and shows the types of housing units and households for which specific tabulations are made. There are also a description of unpublished tabulations and an appendix showing maximum and minimum detail for the categories and class intervals of the individual items.

Data on the sampling rates used for individual items are available in the published reports. Information about the sampling rates for unpublished data will be supplied upon request. Questions about any of the materials described below should be directed to Chief, Housing Division, Bureau of the Census, Washington, D.C., 20233.

### PUBLISHED REPORTS

In the table of contents and in the subtitles below, "series" refers to individual reports published separately for designated areas.

In most instances the various reports in a series are assembled and issued as a bound volume, to which an identifying volume number is assigned. A report for which a volume number is shown, but for which there is no series number, presents material not published as a series of separate reports.

#### Volume I--States and Small Areas, Series HC(1)

This series consists of 55 reports—one for each State, the District of Columbia, Puerto Rico, Virgin Islands, Guam, and a United States Summary.

Because of differences in presentation, there is one subject guide for the summary and another for the remaining reports of the series. In each subject guide, the types of places and areas for which data are published are described in the boxhead.

In the second column of the guide for the State reports, SMSA's and constituent parts means standard metropolitan statistical areas and the subdivisions for which data are published separately. These constituent parts are: each county; each urban place with 50,000 inhabitants or more; the urban balance, i.e., all remaining urban places combined with the urbanized unincorporated areas; and the rural total.

In the case of an SMSA which extends into another State, each State report contains data for the portion within its own boundaries, and also data for the entire SMSA and for the portion in each adjoining State.

Data for units in which the head of the household is nonwhite or is white with Spanish surname or is of Puerto Rican birth or parentage are published for those SMSA's and places having the specified number of such households without regard to the total number of households. Data for units in which the household head is nonwhite are published for each State in which they number 25,000 or more. There are no corresponding State tables for Spanish surname and Puerto Rican households.

In many cases the degree of detail varies with the size of the place or area for which the data are presented. Thus, 10 class intervals plus a median are shown for value of owner-occupied units in the State tables and tables for larger urban places, but only 6 class intervals plus a median are shown for places with 2,500 up to 10,000 inhabitants, and only an average (arithmetic mean) for places with 1,000 up to 2,500 inhabitants.

#### Volume II--Metropolitan Housing, Series HC(2)

This series consists of 202 reports—one for each standard metropolitan statistical area (SMSA) with 100,000 inhabitants or more, one for each of the nine geographic divisions, and one for the United States. The reports for the United States and the geographic divisions have separate tables for the entire area, for the portion within SMSA's (including those with less than 100,000 inhabitants), and for the portion outside of SMSA's.

The reports for individual SMSA's have separate tables for each city of 100,000 inhabitants or more. The reports also have separate tables for any SMSA or city having 25,000 or more housing units in which the head is nonwhite, is of Puerto Rican birth or parentage, or (in California and Texas) is white with Spanish surname.

#### Volume III--City Blocks, Series HC(3)

This series consists of 421 reports—one for each city having 50,000 inhabitants or more in the 1950 Census or in a subsequent special census conducted by the Bureau, and for each of about 200 smaller places which arranged for inclusion in the block statistics program. There is no summary or combined report for this series.

For each block, the report presents statistics based on items collected for all housing units. In tracted cities, the block figures are summarized by census tract; in most nontracted cities, they are summarized by block numbering area.

Each report includes a map showing all blocks.

#### Volume IV--Components of Inventory Change, Series HC(4)

This volume consists of two parts, the first dealing primarily with changes in the housing inventory from April 1950 to December 1959, and the second with changes occurring in the period January 1957 to December 1959.

Part 1 is published as two sets of reports, Part 1A and Part 1B, for the United States and for each of the following 15 standard metropolitan statistical areas (SMSA's) and 2 standard consolidated areas:

The reports for the United States present national totals, with separate tables for the portions within SMSA's, within the central cities of these SMSA's, within the SMSA's but not within the central cities, and outside of SMSA's. These reports also present data for each of the four regions, with separate tables for the portion inside SMSA's and the portion outside of these areas (but without separate tables for the portion within the central cities). The reports for each SMSA or standard consolidated area shows data for the area as a whole, without geographic breakdown.

Part 1A presents basic 1959 and 1950 data for the entire inventory and for major components. Part 1B gives information on additional characteristics of the 1959 inventory but without a breakdown by components. It also contains data on "recent movers" and changes in rents and values.

Part 2 presents for the period January 1957 to December 1959 the same type of data as Part 1. Part 2 consists of 10 reports—one for the United States and its four regions, and one for each of the standard metropolitan statistical areas or consolidated areas for which a National Housing Inventory report was issued.

#### Volume V—Residential Finance

This volume is published in two parts—Part 1 for homeowner properties (properties consisting of 1 to 4 dwelling units, 1 of which is occupied by the owner) and Part 2 for rental and vacant properties. Each part includes a relatively large number of mortgage, property, and owner characteristics which are not included in any of the other volumes. Because of the highly specialized character of the items not in the other volumes, only two of them (amount of first mortgage, and outstanding debt on first mortgage) are included in this subject guide. The subject guide in Volume V lists all residential finance items.

The distributions in Part 1 are limited to properties with 1 dwelling unit. Table 1 of Parts 1 and 2 includes both mortgaged and nonmortgaged properties; the other tables are limited to mortgaged properties.

The units of tabulation in both Parts 1 and 2 are: the amount of first mortgage outstanding debt, for table 3; the amount of total mortgage outstanding debt, for table 4; and the number of properties, for all the other tables.

#### Volume VI—Rural Housing, Economic Subregions

This volume is confined to housing in rural areas; the data omit housing units in urban places, in the unincorporated part of urbanized areas, and in incorporated and unincorporated places having less than 2,500 inhabitants and located in urbanized areas. Data are presented for the United States and for each of 121 economic subregions, bound as a single report.

Statistics are presented separately for occupied nonfarm units and farm units. Since the definition of farm units requires that they be occupied, all vacant rural units are classified as

nonfarm. The table dealing with vacant units is limited to non-seasonal units available for sale or available for rent, with separate data for these two categories. Other vacant units—seasonal, dilapidated, and not on the market for any reason—are omitted.

#### Volume VII—Housing of Senior Citizens

This volume presents data for persons 60 years old and over, households with one or more such persons, and housing units at which the occupants include at least one such person.

The cross-tabulations (1) by size of household by number of persons 60 years old and over in household, (2) by age, and (3) by individual income, are in terms of number of persons; the other cross-tabulations are in terms of number of occupied housing units. Data are presented for the United States areas inside SMSA's, areas outside SMSA's, each State, and the largest SMSA in each State.

#### Series PHC(1)—Census Tracts

This series consists of 180 reports—one for each of the 177 tracted areas in the United States and 3 tracted areas in Puerto Rico. Each report contains population tables and two basic housing tables, plus an additional housing table if there is a census tract having 100 or more housing units in which the head of the household is nonwhite, and another additional housing table if there is a tract in Arizona, California, Colorado, New Mexico, or Texas, with 400 or more housing units in which the head of the household is white with Spanish surname or in other States, a tract with 400 or more housing units in which the head of the household is of Puerto Rican birth or parentage.

Statistics on automobiles available are shown only for tracts within the corporate limits of places with 50,000 inhabitants or more. Information on this item was collected for a 20 percent sample of households in such places, but for a 5 percent sample elsewhere.

#### Series HC(S1)—Special Reports for Local Housing Authorities

This series is a supplement to the 1960 Census of Housing, arranged at the request of the Public Housing Administration. Each report was made at the request of a local housing authority or other local government agency, which specified the area to be covered and paid the cost of the operations required. The series consists of individual reports for 139 areas, plus a summary report.

The tables are limited to occupied housing units classified as substandard according to Public Housing Administration criteria, and to the occupant households. Table 1 presents housing and occupancy characteristics of all such units by tenure and color, with separate statistics for those in which the head of the household is 65 years old or over. The remaining tables deal solely with household and financial characteristics of substandard units occupied on a rent-paid basis by primary families.

UNPUBLISHED TABULATIONS

Unpublished tables in 11 series designated as PH-1 to PH-11 provide data for small areas.<sup>1</sup> The housing items of PH-1, PH-2, and PH-8 to PH-11 are shown in the tabular presentation at the right.

The PH-1 and PH-2 tables have been made for all census tracts, and the PH-1, PH-8, PH-9, PH-10, and PH-11 tables have been made for all pseudo tracts. These pseudo tracts, which cover the entire untraced area of the United States, are:

- Wards of each city of 25,000 or more inhabitants for which wards have been established
- Each city of 25,000 or more inhabitants for which wards have not been established
- Each urban place with 2,500 to 25,000 inhabitants
- Each township, census county division, or other minor civil division, exclusive of any urban place.

Photocopies of these tables can be supplied in about a week. Table PH-1 is also available in microfilm form for all tracts and pseudo tracts.

Table PH-1 can be provided for enumeration districts in all urban places and rural areas, whether tracted or not. The enumeration district tables are made only on order, and can be supplied in about three weeks.

All of the foregoing are standard unpublished tables for which price scales have been established. In addition, numerous individually designed tabulations have been made to meet needs for specialized data and are available on a cost basis. The time required depends on the volume and kind of operations needed, and the workload of other tabulations.

Unpublished tabulations from the 1960 Residential Finance Survey include tables for the United States for 1- to 4-dwelling unit properties comparable to the published tables for 1-dwelling-unit homeowner properties; selected characteristics of junior mortgages, including type and size of property and type of mortgage holder; and a series of cross-tabulations for the United States for all homeowner properties, for mortgaged properties by mortgage status, and for other categories of properties. A detailed list of these cross-tabulations is available on request.

A self-weighting, one-in-a-thousand (0.1 percent) sample of individual census records is available on computer input tapes and also on a set of punchcards, from which users may make tabulations suited to their requirements. Identifying information for persons, households, and housing units is omitted; area identification is limited to geographic region and size classification of the locality.

The computer tape is a 120-character record for each of approximately 180,000 persons, and presents most of the population items covered in the 25-percent decennial sample. The tape also presents selected household and family characteristics, a few characteristics of an "associated" person (spouse of a married person in the sample; parent of a child in the sample), and selected characteristics of the housing unit.

Most (but not all) of the same data are provided on a set of 80-column punchcards. Each card carries a household and family number to permit assembly of the cards for all members of the same household and compilation of household or family data.

The price for this material in either computer tape form or punchcard form is \$1,500.

There is also a self-weighting, one-in-ten-thousand (0.01 percent) sample available only as a set of approximately 18,000 punchcards. The information recorded is the same as on the punchcards in the one-in-a-thousand sample. The price for the set of 0.01 percent sample punchcards is \$500.

Persons wanting more detailed information about these sample tapes or punchcards, or having questions about contemplated special tabulations, or wanting additional information about any of the PH series of unpublished tables should address their inquiries to Chief, Housing Division, Bureau of the Census, Washington, D.C., 20233.

A pamphlet entitled "Inventory of Machine-Readable Data and Selected Tabulations" describes detailed information in the files of the Bureau of the Census that can be made available on computer tapes and/or on punchcards for the cost of transcribing or reproducing the statistics. Included in the "Inventory" are descriptions of a number of tabulations and records that were used to compile the published reports on the 1960 Census of Housing. The pamphlet is free and a copy may be requested from the Publications Distribution Section, Bureau of the Census, Washington, D.C., 20233.
