PREFACE

The Alphabetical Index of Occupations and Industries is designed for use in classifying the occupation and industry returns from the Population Censuses and demographic surveys conducted by the Bureau of the Census. The Index lists occupation and industry titles as they appear on the Census and survey schedules, together with a numerical or letter code indicating the appropriate occupation or industry category in which each title is to be classified. The occupation and industry titles shown here in alphabetical arrangement are presented according to the category in which each title belongs in a companion volume, the Classified Index of Occupations and Industries.

A new Index is prepared for each Decennial Census of Population. The current edition replaces the 1950 edition. The occupational and industrial classification systems used in the Index are revisions of the 1950 systems.

The basic content of the 1960 Index, like that of other editions, is largely derived from previous editions. The 1960 Index represents generally an expansion of the 1950 Index with some revisions based primarily on the experience acquired during the Population Census pretests and sample population surveys conducted by the Bureau since the 1950 Census. In addition, much valuable material was obtained from sources such as the Dictionary of Occupational Titles published by the United States Employment Service and the Standard Industrial Classification published by the Bureau of the Budget.

Many individuals and organizations, both private and public, were of assistance in the preparation of the Index. Their kind cooperation is gratefully acknowledged. Special acknowledgment is due to the Interagency Occupation Classification Committee of the Bureau of the Budget, and to the Committee's chairman, Dr. Gladys L. Palmer of the University of Pennsylvania, and Harold T. Goldstein, Office of the Assistant Director for Statistical Standards, who assisted in the planning of the industry material.

This Index was prepared in the Occupation and Industry Statistics Section under the supervision of Dr. Stuart Garfinkle, Chief, Economic Statistics Branch of the Population Division, by William J. NOTE ON REVISED EDITION

The revisions in this edition are mainly additions to the list of titles and are a result of the experience of the early months of the processing of the 1960 Population Census schedules. The revisions include corrections for the small number of typographical errors, additions of a few new titles, and several changes in the listings of permissible occupation-industry code combinations. Few, if any, of these changes will have any effect on the final published statistics.
