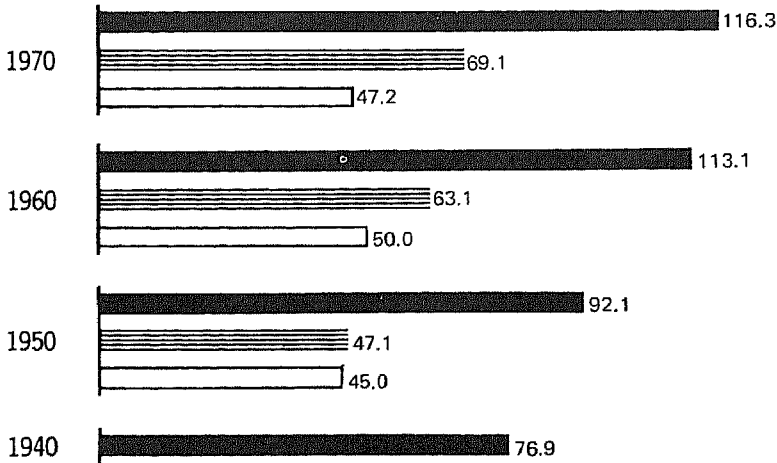

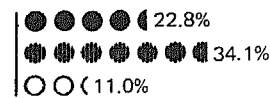

### PLUMBING FACILITIES AND PERSONS PER ROOM: Percent

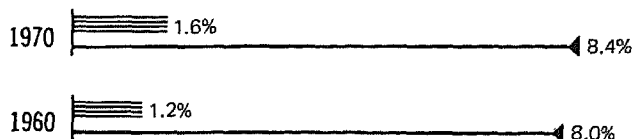
